## **Code of honor**

I will respect the individual feelings of closeness and distance, the privacy and personal boundaries of shame of the children, young people and adults entrusted to me, as well as those of other club members.
  
- I will guide children, young people and adults in their self-realization to appropriate social behaviour towards other people. I would like to educate them to behave fairly and respectfully towards people and animals both inside and outside of sporting activities and to treat nature and the environment responsibly.
  
- I will always adapt sporting and non-sporting activities to the level of development of the children, young people and adults entrusted to me and use appropriate methods.
  
- I will always try to create fair conditions for the children, young people and adults entrusted to me for sporting and non-sporting activities.
  
- I will respect the right to physical integrity of the children, young people and adults entrusted to my care and will not use any form of violence, be it physical, psychological, emotional or sexualized.
  
- I will ensure that the rules of the respective dance sport disciplines are adhered to. In particular, I will act as a positive and active role model in the fight against doping and drug abuse as well as against any kind of performance manipulation.
  
- I offer the children, young people and adults entrusted to me sufficient opportunities for self-determination and co-determination in all sporting and non-sporting activities.
  
- I respect the dignity of every child, young person and adult and promise to treat all people equally and fairly, regardless of their social, ethnic and cultural background, ideology, religion, political beliefs, sexual orientation, age or gender, and to firmly oppose discrimination of any kind and anti-democratic ideas.

## **Legal notice for photographers**

### **Revocation of the photo license in the event of discreditation**

The photographer undertakes, at the request of Grün-Gold-Club Bremen e.V., to immediately cease the use and distribution of the images concerned and, if technically and legally possible, to withdraw images that have already been published. From the time of revocation of the photo license, any further publication or other use of the photographs concerned is expressly prohibited.

Should the photographer fail to properly comply with this instruction or otherwise fail to comply with the reasons for revocation, Grün-Gold-Club Bremen e.V. reserves the right to assert claims for damages. This includes, in particular, legal steps that serve to enforce the interests of Grün-Gold-Club Bremen e.V. and to protect the persons concerned. This includes the initiation of warning procedures, the application for interim injunctions or the filing of an action for injunctive relief and the assertion of claims for damages to the full extent permitted by law. All legal costs and expenses arising from the enforcement of protective measures may be charged to the photographer in accordance with applicable law.
